Description of the Prior Art The proliferation of the Internet has contributed to an increase in the popularity of voice over IP (VoIP) communication systems. For example, assuming the range of IP addresses, known as Class A addresses, start with 10.0.0.0 and end with 10.255.255.255, then there are 2147 addresses available for use with the IP protocol. However, if a single IP address is used to represent a unique endpoint, then there are only 2127 available IP addresses. Thus, for example, if 100 users have IP addresses starting with 10.0.0.0 and ending with 10.255.255.255, then only 99 users would have enough IP addresses for use with the IP protocol, but all 100 users would have a single IP address. As a result, the single IP address cannot uniquely identify any one of the users. To address this problem, unique identifiers such as the phone number or a media access control (MAC) address have been employed with the IP protocol. The phone number can be assigned to an endpoint by the particular telephone carrier or a VoIP telephony provider. Alternatively, the MAC address
